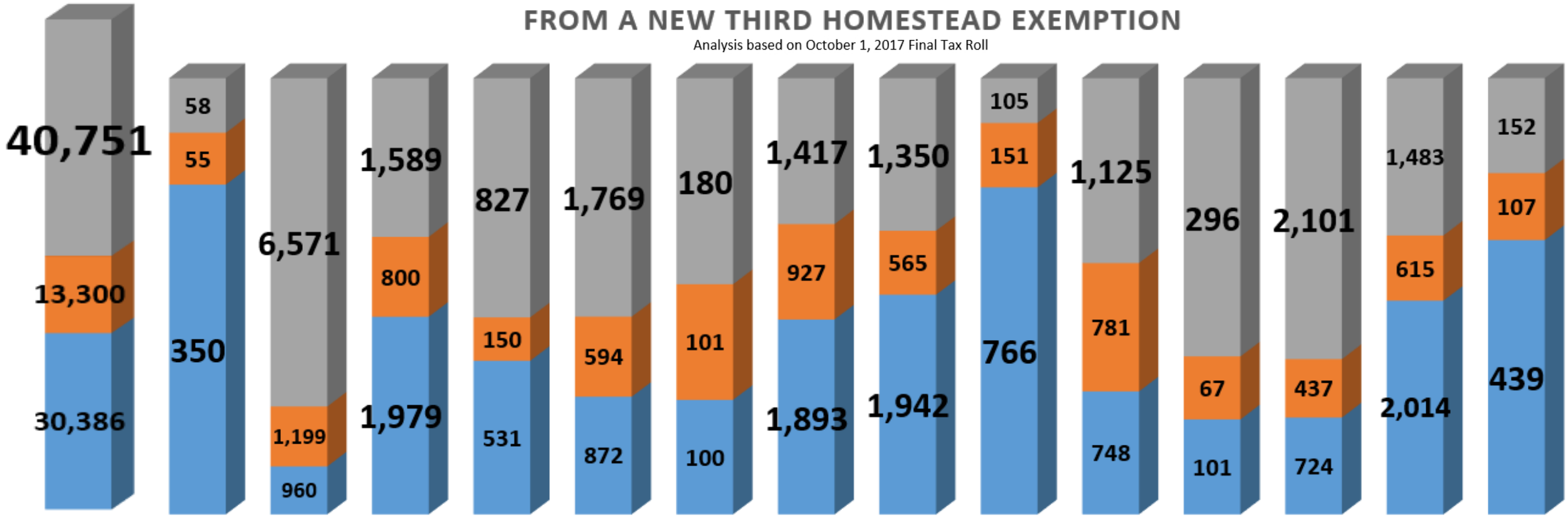

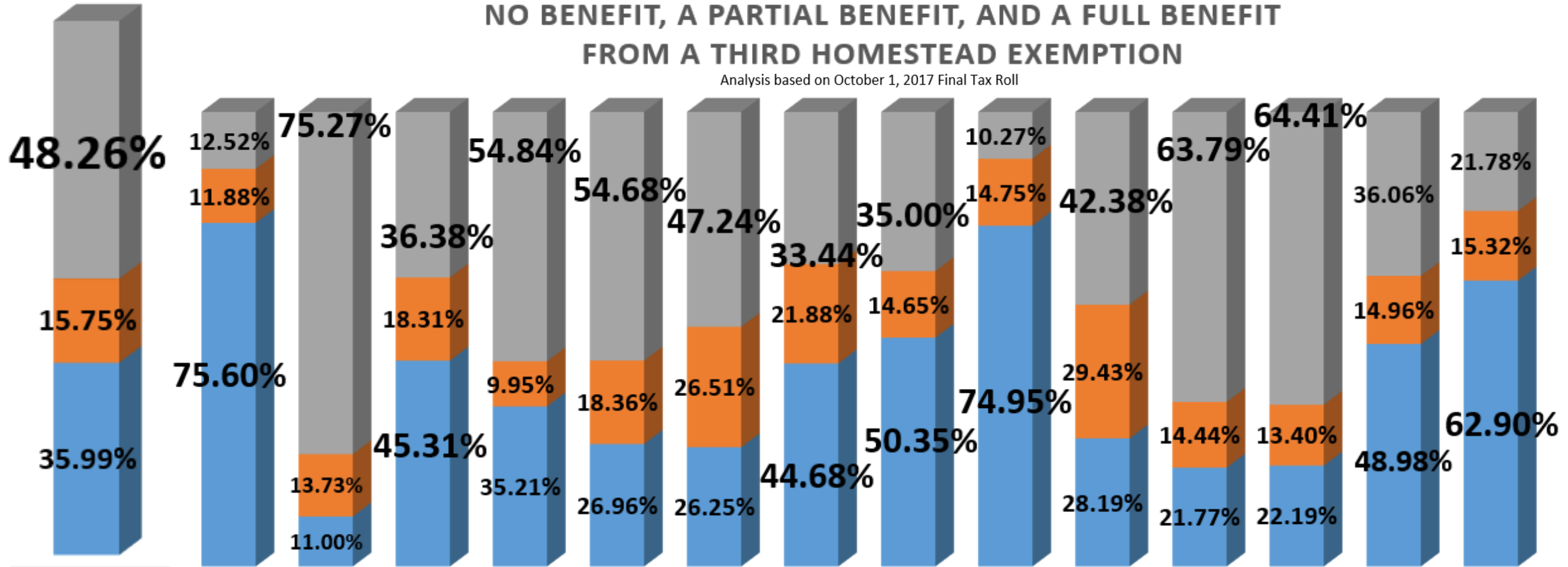

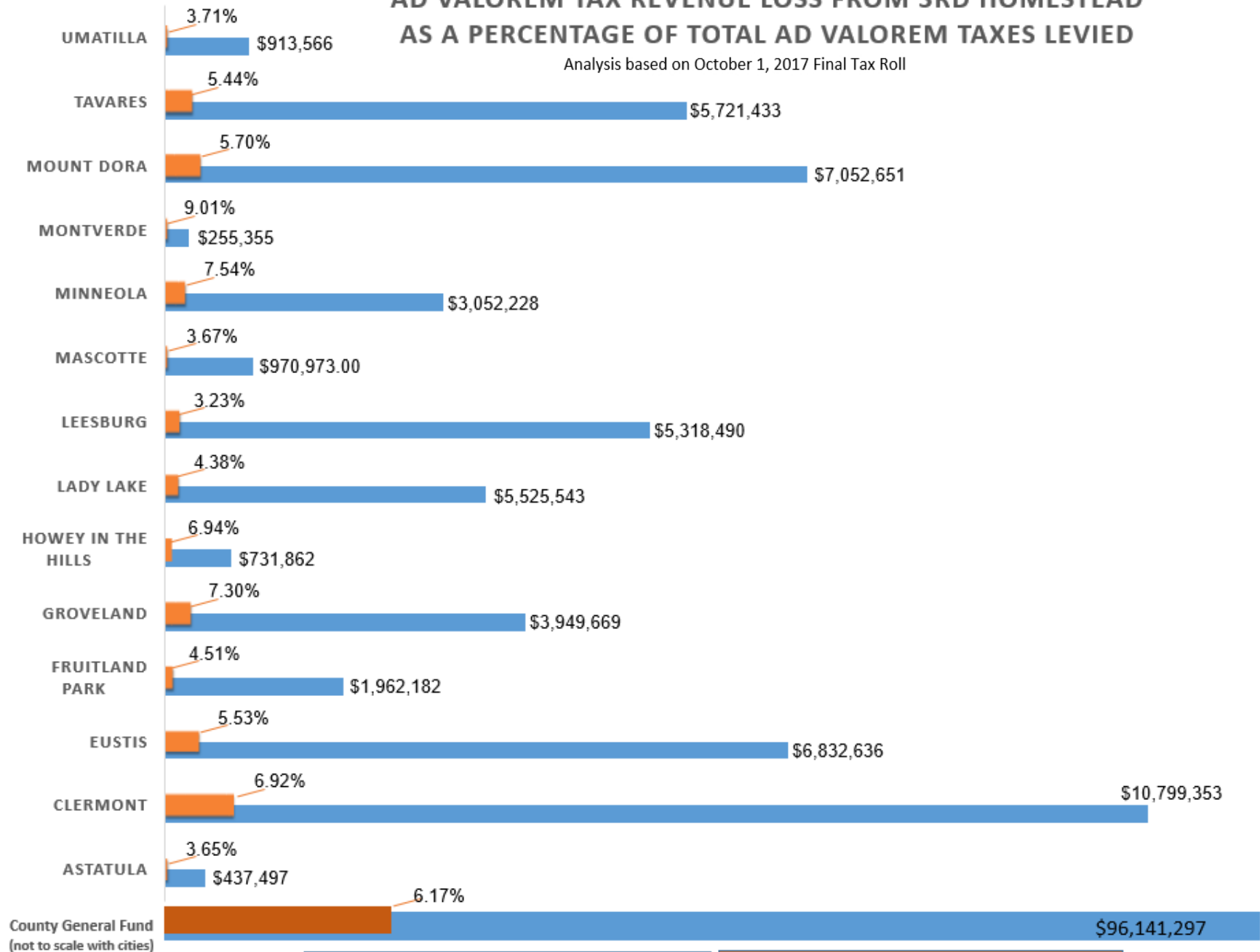

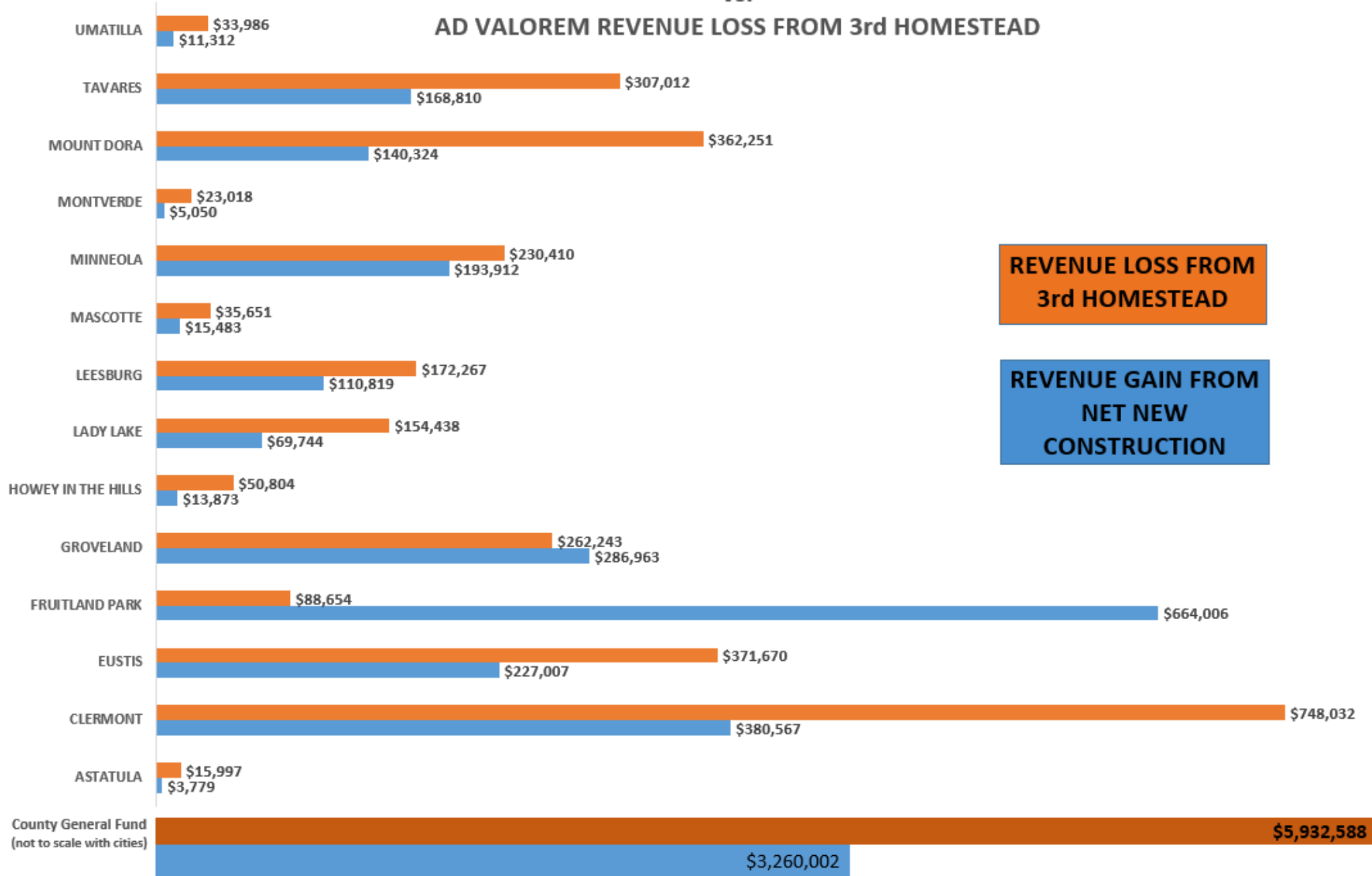
2017 Ad Valorem Taxes Levied
